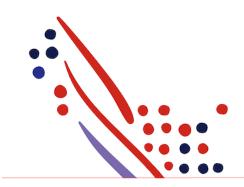



This issue comes up when adding a template with the status of InProgress and having required field information. Then, the same template ID, workerID, and file number is used and changes the status to complete with same information provided beforehand.

This adds a new record in the ADP Workforce Now UI.

## Issue Description

There is no validation that happens when assigning a non manager to an employee via the Applicant Onboard V2 API for WFN

#### Work around

This can be done through workforce Now UI.

#### Limitation:

when I POST to <a href="https://api.adp.com/hcm/v2/applicant.onboard/">https://api.adp.com/hcm/v2/applicant.onboard/</a> to create an in-progress applicant and pass a value for recordingBasisCode it always shows up at WFN as "Salary" regardless of what I send. This happens even when I send a nil/blank value for recordingBasisCode.

I've tried this sending "1" (hourly), "4" (daily), "8" (salary), "" (blank), and nil (also blank). In all cases, it shows as "Salary" in the "Regular Pay Rate" field of WFN.

My understanding is that these are the correctly mapped values to be sending for recordingBasisCode:

So I'm not sure if something isn't working right at WFN with these values.

#### Solution:

If we provide "payPeriodRateAmount" in the payload it will consider the value by default as "salary". To get Hourly/Daily we need to provide "hourlyRateAmount/dailyRateAmount" under baseRemuneration section in the request payload. Please see the below payload request example for hourlyRateAmount. Basis of pay is used for reporting. What determines how the employee is actually being paid is based on what is sent in the baseRemuneration Daily -/applicantOnboarding/applicantPayrollProfile/baseRemuneration/dailyRateAmount/amount Hourly -/applicantOnboarding/applicantPayrollProfile/baseRemuneration/hourlyRateAmount/amount Salary -/applicantOnboarding/applicantPayrollProfile/baseRemuneration/payPeriodRateAmount/amount
