



The canonical URI corresponding to the API needs to be added in the Consumer Application Registry (CAR) for the subscription. Following which, a user can access this API and make successful API calls.

The following canonical needs to be added to your application scope to enable this use case: /benefits/benefitsManagement/benefitsElectionManagement/beneficiaryManagement/beneficiary.read

The following are the steps shown in the above diagram:

- 1. The consumer application makes a /benefits/v1/associates/{aoid}/beneficiaries request to the ADP API endpoint.
- 2. The ADP API endpoint responds to the consumer application concerning the details of /benefits/vl/associates/{aoid}/beneficiaries.
