



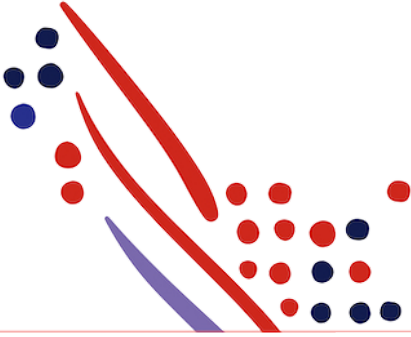

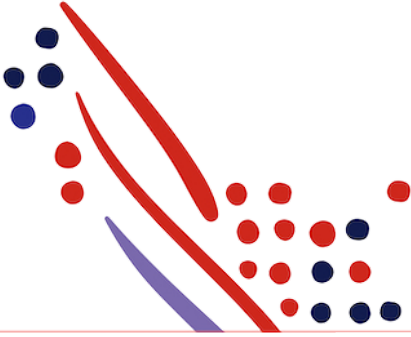

1	Client Practitioner	Triggers the API-based data exchange between your application and ADP WorkForce Now.
2	Your Application	Update Corporate Group Details of an employee by calling the Corporate Groups API.

# Use Case: Updating an Employee's Corporate Group Details

## Use Case Description

This use case describes on how to use Corporate Group API to update corporate group details like

- Corporate Group Change Reasons
- Home Department number
- Home Cost number
- Business Unit
- Union Code
- Union Local
- Location
- Business Eligibility Class

The change is made with respect to an effective Date. For example, the changes are effective from the date which you provide in the **effectiveDate** field of the API request payload provided in this use case.

## Application Scope

The canonical URI corresponding to the API needs to be added in the Consumer Application Registry (CAR) for the subscription following which a user can access this API and make successful API calls.

The canonicals in the following table need to be added to your application scope to enable this use case:

## Request Header Parameters

None, in addition to the ADP standard header parameters.

## Sequence of Interactions

1. Your consumer application makes a request for **/hr/worker-profile/v1/workers/{associateoid}/work-assignments/{assignment-id}/corporate-groups/meta** to the ADP API endpoint.
2. The ADP API endpoint responds to your consumer application with the meta payload. Your consumer application processes the meta payload to validate data included in the payload in step 3 and prompts the user to fix any validation issues. Otherwise, compose the payload for the **POST /hr/worker-profile/v1/workers/{associateoid}/work-assignments/{assignment-id}/corporate-groups** request.
3. Your consumer application makes a **/hr/worker-profile/v1/workers/{associateoid}/work-assignments/{assignment-id}/corporate-groups** request the ADP API endpoint.
4. The ADP API endpoint responds to the consumer application concerning the details of **/hr/worker-profile/v1/workers/{associateoid}/work-assignments/{assignment-id}/corporate-groups**

### Chapter 3

## Known Issues and Limitations

Issue #1: reasonCode codeList of meta displays both active and in-active codes

### Issue Description:

The **reasonCode** codeList of meta is displaying both active and inactive codes, but there is no active or inactive indicator in the meta response. This will be fixed in future enhancements.

## Suggested Workaround

There are no workarounds available.

Issue #2: The meta API states that **reasonCode** is optional, but when an update is attempted, corporate group details are returned without a reason code and the API is throwing an error

## Issue Description

The Corporate Groups API is treating the reason code as mandatory, whereas the meta states it's optional. This issue will be fixed in future enhancements.

Issue #3: Event notifications are not supported by this API
