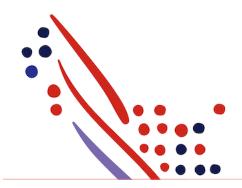



Summary

APIs listed in this use case allow applications to retrieve data from the Validation tables related to Payroll Management.

Application Scope

The canonical uniform resource identifier (URI) corresponding to the APIs listed in the following section need to be added in the Consumer Application Registry (CAR) for the subscription following which a user can access these APIs and make successful API calls.

The following canonical needs to be added to your application scope to enable the API's listed in the following sections:

/payroll/payrollManagement/payrollInstructionManagement/codeListViewing/codelist.read

API Usage

Data Control API

The client practitioner can manage data controls in the ADP Workforce Now user interface (UI) by selecting **Setup > Tools > Validation Tables > Payroll > Other Pay Settings > Data Control**. Data Control codes identify employees for special reasons.

Clock API

Clock codes identify employees for special reasons. If you need to add or delete a Clock code used in a special calculation, benefit accrual, or in your management reports setup, contact your ADP service team.

Canada Tax Province or Worked in Province Code API

- New Hire > Tax > Provincial > Worked in Province

Note: Applicable to Canadian employees. The client user can't add them in validation tables, but can view them on employee pay profile or New Hire.
