



Issue 1: Inactive codes are not returned for the NAICS Workers Compensation CodeList API

Impacted APIs

For API related information please refer WFN Custom Codelists under API Explorer.

Issue Description

The codes retrieved using NAICS workers Compensation CodeList API doesn't include in-active codes.

Suggested Workaround

There are no workarounds available.

Issue 2: Error handling for invalid filter value

Impacted APIs

All codeList APIs are impacted.

Issue Description

When an invalid filter is passed along with the CodeList URI. For example, **?\$filter=category eq 1W6** (Category sent without quotes) then the API should return a 400 Bad Request. Instead, it's responding with a 500 Internal Server error.

Suggested Workaround

There are no workarounds available.

Issue 3: For a few deductions, the deduction configuration codeList API response doesn't display the exact deduction category present in ADP Workforce Now

Impacted APIs

Issue Description

For a few deductions set up under category's like **MedicalFSA**, **DependentCare FSA**, and so on in ADP Workforce Now, the **deductionCategoryCode** is displayed as **Other** in the API response.

However, the following are the categories displayed exactly as configured in ADP Workforce Now:

- Deposit
- Garnishment
- Bankruptcy
- Tax Levy
- Medicare Surtax

This will be fixed in the future enhancements.

Suggested Workaround

The user can cross check the category in ADP Workforce Now, if the **deductionCategoryCode** API response is displayed as **Other**.
